Wilmington Renaissance Corporation (WRC) seeks board members representing companies located or doing business in or adjacent to the City of Wilmington. Effective board members have strong relationship-building skills and the ability to influence others. Board meetings are held quarterly and members are asked to select and serve on a Committee that best matches up with their area of expertise and interest; Finance, Personnel, Audit, Nominating, Development and Communications; support WRC sponsored events and programs through sponsorship and/or ticket purchases; aid in identifying and recruiting companies to either join the board or support WRC sponsored events and serve as an ambassador for Wilmington – i.e., be a positive voice for the city and WRC.

This support is vital, strengthening our capacity for us to

develop and execute programs, events and initiatives that make Wilmington an even better place to live, work, play and learn.

Director Membership

Director members are full voting members of the WRC Board of Directors. You are asked to attend all quarterly meetings as well as the annual meeting. In addition, you are eligible to participate on WRC Board Committees. You will receive regular updates about WRC activities and initiatives; your membership will be noted in WRC's annual report and on its website; and you will receive advance notice of WRC events. Director Membership fees are as follows:

Fewer than 10,000 employees: \$75,000

Fewer than 7,500 employees: \$60,000

Fewer than 5,000 employees: \$45,000

Fewer than 2,500 employees: \$35,000

Fewer than 1,000 employees: \$25,000

Fewer than 500 employees: \$15,000

Fewer than 100 employees: \$10,000

Fewer than 50 employees: \$5,000
